

## AAS-IA & AIG TRAVEL GUARD CAMPAIGN

### TERMS & CONDITIONS

#### 1. Eligibility

- 1.1. This AAS-IA & AIG Travel Guard Campaign (the "Promotion") is from 23 February 2018 to 31 March 2018 (the "Promotion Period").
- 1.2. The Promotion will be administered and run by AIG Asia Pacific Insurance Pte. Ltd. ("AIG") and is only open to Singapore residents.
- 1.3. All AA members who successfully purchase a valid Travel Guard Premier or Superior (Per Trip) plan underwritten by AIG via the link at <http://aas-insurance.com.sg/travel-guard/> during the Promotion Period will each be entitled to a complimentary AIG Travel Adapter ("Gift"). For a Group or Family Plan, only the main policyholder will qualify for the Gift. The plan must be valid at the time of the redemption.
- 1.4. In addition, AA members who successfully purchased any Travel Guard (Per Trip Plan) only via <http://aas-insurance.com.sg/travel-guard/> will be entitled to a 20% discount on such plan purchased.
- 1.5. Employees of AIG and their immediate family members are not eligible to participate in the Promotion.

#### 2. Notification and Redemption

- 2.1. Recipients of the Gift ("Recipients") will be notified within 1 month from the end of the Promotion Period. Redemption letters ("Redemption Letters") will be sent via post to the Recipients' address as indicated in the policy application form.
- 2.2. There will be no re-sending of the Redemption Letters if Recipients fail to receive them from the delivery service provider or fail to claim them within the stipulated time from the delivery service provider.
- 2.3. Upon redemption of the Gift, the Recipients will not be allowed to cancel their Travel Guard policies.

#### 3. Participant's Warranties and Undertakings

- 3.1. Acceptance of the Gift shall constitute consent on the Recipient's part to allow the use of the Recipient's name, image, voice and/or likeness by AIG and/or AAS-IA for editorial, advertising, promotional, marketing and/or other purposes without further compensation except where prohibited by law.
- 3.2. By participating in the Promotion, Recipients agree that any information collected or held by AIG (whether contained in the application form or otherwise obtained) may be used and disclosed by AIG, its associated individuals/companies or any independent third parties (within Singapore) to arrange for the delivery of the Gift. #### 4. Others

- 4.1. AIG shall not be liable in any manner whatsoever for any claims, losses, damages, costs, interests or expenses arising out of the Promotion, the redemption or the terms of use of the Gift.
- 4.2. AIG reserves the right at its absolute discretion to terminate the Promotion or vary, delete or add to any of these terms and conditions from time to time without notice including the basis of offering the Gift, duration of the Promotion and any other matters in respect of the Promotion.
- 4.3. AIG's decision on all matters relating to the Promotion will be at its absolute discretion and will be final and binding on all participants. Except for the Redemption Letters, AIG shall not be obliged to enter into any correspondence on any matter concerning the Promotion. No correspondence or appeals will be entertained. In the event of any inconsistency between these terms and conditions and any brochures, marketing or promotion materials relating to the Promotion, these terms and conditions shall prevail.
- 4.4. This Promotion and these terms and conditions shall be governed by Singapore law and each participant agrees to submit any claim, dispute or controversy to the exclusive jurisdiction of the courts of Singapore.
- 4.5. A person who is not a party to these terms and conditions shall have no right under the Contracts (Rights of Third Parties) Act to enforce any of these terms and conditions.
